THE TERMS AND CONDITIONS ARE SPECIFIED BELOW:

1. Quotation shall be solicited from the registered travel agents only for the above dates & Sectors,
2. All bids must be submitted in a sealed envelope marked as "Quotation for Air Ticket" to the Director General latest by **28th March 2019** before **12 noon** and will be opened on the same day.
3. The rate should be quoted as per the sector given above and will be selected for the most economical route.
4. Airline and seats must be confirmed while submitting the quotation and submit confirmed itineraries.
5. The validation of fares and availability of seats should be as per the details mentioned above.
6. Flexi ticketing, option to change the dates and name of the person in the event of cancellation or postponement of the program after tickets are being issued.
7. Full refund with zero cancellation charge.
8. The successful bidder should submit the photocopy of air ticket along with their invoices for payment.
9. Unconditional quotations like an increase of fares or changes of airlines at the time of travel are not accepted.
10. Tender documents should contain a photocopy of valid trade license issued by Ministry of Economic Affairs.
11. Tenders should be accompanied with a EMD 2 % of quoted amount as earnest money deposit in the form of draft/cash warrant issued in favour of the Dean, Faculty of Traditional medicine, KGUMSB.
12. In case the lowest bidder withdraws his/her bid then the second lowest bidder shall be asked to purchase and issue ticket(s) and the difference amount shall be borne by the lowest bidder.
13. Quotation without EMD and without sealed envelope will be rejected.
14. The purchaser reserves every right to reject the bids if it is found not responsive to our terms and conditions, and the decision of tender committee will be final and binding.
